Concept Maschinenbau GmbH applies for debtor-in-possession insolvency proceedings – PLUTA attorney Dr Lehr appointed provisional monitor

Concept Maschinenbau GmbH, which acquired the business of the insolvent Kiener Maschinenbau GmbH in 2023, has initiated (provisional) debtor-in-possession insolvency proceedings before the competent court.

The company is not involved in regular insolvency proceedings and an insolvency administrator has not been appointed. Management retains its powers of disposition and is responsible for day-to-day operations. Attorney Dr Matthias Lehr from PLUTA Rechtsanwalts GmbH is supporting the restructuring as (provisional) insolvency monitor in the interests of the creditors.

The application has been filed due to a public sector body's surprising decision to enforce legal claims against Concept Maschinenbau GmbH, which stem from the acquisition in 2023 and are directed at the insolvent Kiener Maschinenbau GmbH (in liquidation).

At the time of acquisition and thereafter, these claims were never deemed to be part of the transaction and were therefore not considered in the business plans (earnings,
