# Court opens debtor-in-possession proceedings for the KLINGEL Group: talks with investors ongoing

1 August 2023 · Pforzheim · Business Area: Restructuring

The Local Court of Karlsruhe opened debtor-in-possession insolvency proceedings for the KLINGEL Group today. This means that the multichannel mail-order retailer can continue to pursue its restructuring and its digital transformation strategy.

The relevant measures are currently being developed by the managing directors together with experts at restructuring firm PLUTA. Attorney Mr Martin Mucha from GRUB BRUGGER, a law firm operating throughout Germany, has been appointed insolvency monitor. He had already been acting as provisional insolvency monitor since May and will continue to represent the interests of creditors while monitoring the debtor-in-possession proceedings that are being conducted for the three companies.

In addition to K - Mail Order GmbH & Co. KG, the KLINGEL Group's main company headquartered in Pforzheim, Hamburg-based subsidiaries IMPRESSIONEN Versand GmbH and SCHNEIDER GmbH & Co. KG are also engaged in debtor-in-possession restructuring proceedings.

Talks with potential investors are currently ongoing with the aim of securing the group's future by finding a suitable investor as quickly as possible. Over recent months, the team has analysed the business processes, optimised
