# Good progress in the restructuring of sports club Post SV Augsburg e.V. – PLUTA attorney Georg Jakob Stemshorn receives initial offers

The restructuring of the Post SV Augsburg e.V. sports club is proceeding as planned. Provisional insolvency administrator Mr Georg Jakob Stemshorn from PLUTA Rechtsanwalts GmbH has confirmed receipt of several non-binding offers from interested parties in the first phase of the process of finding an investor. The intention is to put the club on a viable footing and work out a sustainable solution within the framework of an insolvency plan.

The Local Court of Augsburg (insolvency court) ordered provisional insolvency administration for the Augsburg-based sports club in mid-February. Restructuring expert Mr Georg Jakob Stemshorn was appointed provisional administrator.
