### Investor found for E-Mobility Start-Up eluminocity

Wirelane GmbH, a well-known company specialising in the development of e-charging stations, has taken over the business operations of the Munich-based start-up, absorbing the 13 members of staff and the entire management with effect from 1 January 2019.

eluminocity GmbH is an innovative start-up involved in the development of e-mobility and the supporting technology. The young enterprise uses the nationwide street lighting infrastructure as the basis for the specially developed Smart City sensor technology as well as charging stations for electric cars.

The company filed for debtor-in-possession proceedings in 2018 as the lack of bridging funds led to a liquidity shortfall. Following this, the Local Court of Munich ordered proceedings on 8 November 2018 and appointed Dr Max Liebig from the law firm JAFFÉ Rechtsanwälte
