challenges in the past. Its sales declined significantly in the second half of 2023. At the same time, rising costs and, in particular, high material prices are having a detrimental impact.

The 53 employees have been informed by management about the current situation and the need to restructure the company. The employees' wage and salary entitlements are guaranteed for three months thanks to specific substitute benefits provided under German insolvency law. Once the company had filed for insolvency, customers and suppliers were also informed. They are keeping faith with it and support its efforts to continue operating. Several customers have placed new orders in recent days, which is very important in the current phase.

PLUTA attorney Mr Patrick Meyerle said, "The company has already been able to secure several important new orders in the past three weeks while the proceedings have been underway. This gives me confidence as we look for an investor. We have already received initial enquiries from interested parties." In addition to Mr Meyerle, the PLUTA restructuring team includes business lawyer Mr Holger Christian Buehler. Dr Michael Saatmann from consultancy INTRION Gesellschaft für Managementberatung mbH is assisting in the search for an investor.
