Outdoor education provider plans to restructure as a debtor in possession

erlebnistage gGmbH is repositioning itself strategically for the future. It is aiming to achieve a sustainable restructuring that will secure its long-term competitiveness and future viability. To this end, the company filed for debtor-in-possession proceedings. The Local Court of Goslar assented to this application and ordered provisional proceedings on 19 December 2024.

Debtor-in-possession proceedings are in-court restructuring proceedings to rescue and rehabilitate financially distressed companies. Management remains in charge and guides the company concerned through the proceedings itself with support from external experts. Restructuring experts Mr Philip Konen and Mr Ludwig Stern from PLUTA Rechtsanwalts GmbH have been appointed general agents. Their task is to support and implement the restructuring process. They are assisting management within the framework of the debtor-inpossession proceedings. The court has appointed Mr Tobias Hartwig from law firm Schultze & Braun as provisional insolvency monitor. His role is to supervise the proceedings in the interests of creditors.
