### **PLUTA attorney Daniel Barth seeks investor for Nuremberg restaurants**

The company is continuing to operate, and both its TINTO and Brasserie Simone restaurants are open to diners. Its food trailer is also in use and customers can continue to avail themselves of its catering service.

TINTO GmbH operates a restaurant of the same name (TINTO – tapas y vino) in Lessingstrasse, which has been serving Spanish tapas and a varied menu since 2011. Located centrally on the premises of the DB Museum, the restaurant can seat up to 100 people and has a large terrace.

Since 2022, the company has also been running Brasserie Simone on Europaplatz square, which offers regional and sustainable cuisine. Fresh dishes that vary according to the season are served in a beautiful ambience with wood and Art Deco elements.

TINTO GmbH also has a food trailer that brings Spanish tapas to the streets of Nuremberg and can be booked for events. The catering service offered for the DB Museum and others is another mainstay of the business. The company is a certified training organisation for chefs, event managers and restaurant specialists, and employs a total of 22 people whose salaries are guaranteed thanks to specific substitute benefits provided under German insolvency law.

### Search for investor launched

The operating environment for catering businesses has been challenging for some time. TINTO GmbH, too, has been affected by increased costs. The company had to file for insolvency due to liquidity problems, and Mr Daniel Barth was appointed provisional insolvency administrator by the Local Court of Nuremberg.

“The initial discussions with all stakeholders have been positive. Our goal is to preserve the business, so we are looking to bring an investor on board in the near term,” said Mr Daniel Barth in reference to the current situation.
