# PLUTA attorney Georg Jakob Stemshorn achieves agreement in Windhager proceedings

Insolvency administrator Mr Georg Jakob Stemshorn from PLUTA Rechtsanwalts GmbH has achieved a negotiated settlement with BHT – Best Heating Technology in the Windhager proceedings.

Windhager Zentralheizung GmbH based in Gersthofen found itself in a challenging situation after filing for insolvency in March 2024. The business remained operational under difficult conditions. On 1 June 2024, the Local Court of Augsburg, as the insolvency court, opened insolvency proceedings for the company's assets and appointed Mr Georg Jakob Stemshorn as administrator. Previously, Augsburg-based attorney Mr Stemshorn had been acting as provisional insolvency administrator for the company.

Once the stock of spare parts was depleted, customer service operations had to be suspended in early July. In addition, it had become clear in June that the desired takeover by Austrian investor BHT – Best Heating Technology, which had already acquired Windhager's parent company in Austria, would not materialise and there might be legal disputes with BHT – Best Heating Technology.
