# PLUTA attorney Stefan Conrads seeks investor for Harenberg publishing house

The buchreport is a book trade journal that is published in both a print and online edition. Among other things, Harenberg is responsible for preparing the lists of the best-selling books, which are compiled through electronic querying of the merchandise management systems of book shops on behalf of German news magazine DER SPIEGEL.

"The business is continuing to operate," said Mr Conrads. The company has a workforce of 13 employees, who have already been informed of the current situation. A liquidity plan will be drawn up over the coming days. In addition, many discussions are being held with business partners to
