PLUTA attorneys Dr Rigol and Dr Werner support GFO with acquisition of Hilden hospital

St. Josefs Krankenhaus, a hospital in Hilden, has succeeded in beginning the year with a fresh start. Having been involved in debtor-in-possession insolvency proceedings, it has now been acquired by Gemeinnützige Gesellschaft der Franziskanerinnen zu Olpe mbH (GFO). Insolvency expert Dr Ruth Rigol and M&A specialist Dr Norman Werner from PLUTA Rechtsanwalts GmbH advised GFO management on the transaction and are supporting the hospital's integration into the GFO network at this time.

The hospital in Hilden was threatened with closure in 2023. An optimal solution has now been achieved through this transaction, which took effect on 1 January 2024. Together with GFO's St. Martinus hospital in Langenfeld, the two institutions will be run under the new name GFO Kliniken Mettmann-Süd. This means that over 300 jobs at the 183bed facility in Hilden have been saved. Care for patients in the region is assured with the new structure.

Transaction completed within three months

agreement negotiations. The acquisition had to be completed swiftly due to a previously issued closure decision. It was made possible due to the joint efforts of GFO and multiple stakeholders, including the Ministry of Health of North Rhine-Westphalia, funding agencies, the former owner and the insolvency monitor, the mayors and district administrator, and local political bodies.

The acquisition covers the St. Josefs hospital in Hilden, including the hospital property and the building housing the MEDIPLUS specialised medical centre, a healthcare centre with sites in Hilden and Solingen, the Katholisches Bildungszentrum Haan (a nursing training centre) and the Oral and Maxillofacial Surgery Department of the St. Lukas hospital in Solingen.

Dr Ruth Rigol said, "We are pleased that the transaction has been successfully completed and patient care is assured for the future. All stakeholders have cooperated very well in recent weeks to make this solution a reality." Her colleague Dr Norman Werner added, "The acquisition went through very quickly, within just three months. The purchase agreement was executed in less than three weeks after it was signed, which is a remarkable achievement, especially in the heavily regulated healthcare sector."

Among the key undertakings in the coming months will now be to turn the previously independent hospital sites in Hilden and Langenfeld into a sustainably functional and efficient joint hospital and fully integrate this into the GFO network. With this in mind, both locations will not only offer basic and standard care but also in each case cover
