An agreement with the creditors concerning the company's future is expected to be reached by the summer of this year. During the debtor-in-possession proceedings, the company's management team will be supervised by an insolvency monitor. Mr Nils Averbeck, from the business consultancy and business law firm Buchalik Brömmekamp, is active on site and is providing the company's management with support in implementing the restructuring process.

The company filed for insolvency proceedings with debtor-in-possession management in January, especially due to the fact that a major customer had unexpectedly withdrawn.
