# PLUTA expert Frank Schorisch appointed provisional administrator for Familie Gärtner retirement home

Seniorenheim Familie Gärtner GmbH has filed for insolvency. On 19 January 2024, the Local Court of Bielefeld ordered provisional administration for the care provider's assets and appointed Mr Frank Schorisch from PLUTA Rechtsanwalts GmbH as provisional insolvency administrator.

The geriatric and nursing care facility will remain fully operational, ensuring the continued care of the currently 72 residents. It has a capacity of 84 full-time care and 12 day care places and employs 70 people.

Preußisch Ströher Service GmbH, a service provider for the retirement home that offers kitchen and catering services in particular, is also involved in provisional insolvency proceedings. It has 25 employees.

The salaries of the combined 95 employees are guaranteed for a period of three months thanks to specific substitute benefits provided under German insolvency law.

Provisional administrator Mr Schorisch from PLUTA Rechtsanwalts GmbH said, "We have informed the

employees and residents about the current situation. Business operations are being maintained and all residents will continue to receive the usual level of care." The retirement home in Rahden, North Rhine-Westphalia, has had to file for insolvency due to imminent illiquidity resulting from steep cost increases. Shortages of skilled workers have also put a strain on operations. "We will get an overview of the financial situation over the coming days and review all options for preserving the retirement home," said Mr Schorisch.
