He is currently reviewing the restructuring options and initiating a structured process of finding an investor.

The company has a workforce of more than 30 employees. Management has informed them about the current situation. Their salaries are guaranteed until the end of August thanks to specific substitute benefits provided under German insolvency law.

The provisional insolvency administrator has launched the process of finding an investor within the framework of a structured M&A approach with a view to achieving a sustainable continuation solution.
