PLUTA restructuring expert Dr Kaufmann appointed provisional administrator for Vynova Wilhelmshaven GmbH

Vynova Wilhelmshaven GmbH has filed for insolvency. On 12 December 2025, the Local Court of Wilhelmshaven ordered provisional insolvency administration for the company's assets and appointed Dr Christian Kaufmann from PLUTA Rechtsanwalts GmbH as provisional administrator.

The PLUTA team is already on site at the company and gaining an initial overview. The members have held early discussions with management and are examining the continued operation of the business. They will also soon arrange for pre-financing of the specific substitute benefits provided under German insolvency law to ensure that the employees receive their pay.

Employee salaries guaranteed

The business employs around 360 people, whose salaries are guaranteed for a period of three months to the end of February 2026 thanks to the specific substitute benefits mentioned. Management already informed the employees about the application for insolvency yesterday.
