PLUTA restructuring expert Dr Kaufmann holds discussions with interested parties regarding Vynova Wilhelmshaven GmbH

In the Vynova Wilhelmshaven GmbH proceedings, provisional insolvency administrator Dr Christian Kaufmann from PLUTA Rechtsanwalts GmbH has provided an update on the ongoing process of finding an investor.

Dr Kaufmann stated that multiple interested parties have submitted non-disclosure agreements, and some initial indicative offers have already been received. Further negotiations will be held on the basis of the offers. The structured process of finding an investor is being supported by Deloitte GmbH Wirtschaftsprüfungsgesellschaft, represented by Dr Stefan Weniger and Merlin Smeenk.

On 12 December 2025, the Local Court of Wilhelmshaven ordered provisional insolvency administration for the company's assets and appointed Dr Christian Kaufmann from PLUTA as provisional administrator. The PLUTA team has held numerous discussions in recent weeks to facilitate business continuity.

Attorney Dr Christian Kaufmann said, "We have managed to stabilise the business despite a number of challenges,
