# PLUTA restructuring expert Dr Kaufmann secures future of BCM tree nursery in Lower Saxony

Dr Christian Kaufmann from PLUTA Rechtsanwalts GmbH has achieved a solution for BCM tree nursery from Westerstede, Lower Saxony, having kept the longestablished tree nursery operating for a year. The present owner Mr Christoph Marken will acquire BCM's assets within the framework of a restructuring via insolvency plan; the financing agreement needed for this has been recently concluded. The business located in the Ammerland region will thus continue operating under the same name and producing nursery plants on over 65 hectares of land.

Subject to approval of the insolvency plan, the administrator therefore expects it will be possible to terminate the proceedings towards the end of the year. "We have held numerous discussions over recent months. The negotiations have been very constructive and the agreement is the best possible outcome for the company. A total of 80 jobs will be saved through the solution agreed," said PLUTA attorney Dr Kaufmann, summarising the situation.

BCM Baumschule Christoph Marken GmbH & Co. KG filed for insolvency with the Local Court of Oldenburg in summer 2022. In the autumn, the court opened insolvency proceedings for the company's assets and appointed attorney Dr Christian Kaufmann from PLUTA as administrator. He has since kept the business operational together with his PLUTA team, which also includes attorney Ms Christine Behrens and business lawyer Ms Nicole Neumerkel.
