PLUTA Restructuring Expert Dr Lehr finds Investor for Lift Component Supplier

The insolvency administrator Dr Matthias Lehr from PLUTA Rechtsanwalts GmbH has succeeded in finding an investor for SLC Sautter Lift Components GmbH & Co. KG. With effect from 1 July 2018, business operations will be taken over by the newly founded company Sautter Lift Components GmbH by means of an asset transfer. Ms Alexandra Sautter, previously responsible for human resources and legal affairs, will become managing director and principal partner of the new company. 25 per cent of the equity interests will be acquired by long-standing employees of the company.

The corresponding purchase agreement was signed by the persons responsible yesterday. It has been agreed that the purchase price will not be published. Dr Lehr and the Sautter Family informed all of the members of staff about this solution during a staff meeting. 20 employees will be kept on by the new company. Five employees had to be laid off, ten others left the company at their own request in order to follow a new career path.

The company based in Kornwestheim manufactures components for lifts, supplying mechanical and electrical products to all major players in the industry. The company's portfolio includes, for example, safety components such as safety gears or elevator car frames and a variety of spare

SLC Sautter Lift Components had to file for insolvency in February, due to a liquidity shortage. By its order of 9 February 2018, the Local Court of Stuttgart has appointed Dr Matthias Lehr as the provisional insolvency administrator. On 1 April 2018, the proceedings were opened, with the PLUTA attorney Dr Lehr being appointed as the administrator. Major restructuring measures have been implemented over the past weeks and months. For example, the company is focusing on its core competencies and profitable product lines.

The attorney Dr Lehr from Stuttgart said, "We have achieved the best possible solution for everyone involved. This is a very positive result. The new company is well prepared for the future and may continue the business seamlessly, benefiting from the good order situation of its predecessor."
