Restructuring Expert Michael Pluta appointed as provisional Administrator for Tour Operator H&H Touristik

February 8, 2019 · Karlsruhe · Business Area: Insolvency Administration

- Trips starting on or before 20 February 2019 will go ahead
- The salaries of the roughly 80 employees are guaranteed

By an order issued on 6 February 2019, the Local Court of Karlsruhe has appointed Mr Michael Pluta from PLUTA Rechtsanwalts GmbH as the provisional insolvency administrator for H&H Touristik GmbH. Filing for insolvency became inevitable for the tour operator due to liquidity problems.

The attorney Mr Pluta and his team are in the process of establishing an initial overview of the situation. The restructuring experts are already present in the company and are in close contact with the insurer, HanseMerkur. "The entire team is working hard to ensure that holiday makers, who have already booked trips, can travel as planned. Trips starting on or before 20 February 2019 are guaranteed to take place," said the restructuring expert Mr Michael Pluta. In individual cases, it may be necessary to change flight bookings with Germania, due to the carrier's insolvency. Affected passengers will be informed directly.

In total, the company has a workforce of approximately 80

Travellers are protected by insurance

Around 10,000 trips are affected by the insolvency. Customers are protected by travel insurance. In the event of cancellation, travellers can contact the insurer HanseMerkur Reiseversicherung AG for compensation.

Under an agreement entered into between the tour operator, HanseMerkur and the provisional insolvency administrator, every effort is being made to ensure that all trips starting on or before 20 February 2019 will take place. The costs of these trips have already been paid or will be covered by HanseMerkur. The contracted hotels and transfer providers will be informed of this. Customers will not be required to meet the costs of these services during their stay.
