The debtor-in-possession team has found an investor for e-cargo bike sharing provider sigo, a company with operations all across Germany. The newly established sigo green GmbH will acquire the business by way of an asset deal. All of the jobs have been saved. The parties have agreed not to disclose the purchase price of the transaction.

Mr Felix von Borck, a well-known entrepreneur and the founder of Akasol AG, is behind the new company. The investor has extensive experience in electromobility and in business creation and development. With his expertise and a new management team, the new sigo green will be guided to planned growth and profitability. The investor sees great potential for the start-up. "The sigo business is now on a more solid footing than ever," said Mr Felix von Borck.

With a network of inductive charging stations, sigo green GmbH based in Darmstadt is one of Germany's first providers of a fully automatic e-cargo bike system. The company operates a B2B2C business model. It is working together with the housing industry and municipalities to drive forward the transition to e-mobility. sigo has played

For this purpose, sigo filed a corresponding application, and the Local Court of Darmstadt approved the provisional debtor-in-possession proceedings in June 2023. Regular proceedings were opened on 1 August 2023 as planned.

Debtor-in-possession proceedings are in-court restructuring proceedings to rescue and rehabilitate financially distressed companies.
