The debtor-in-possession proceedings for ZEDO GmbH, the operator of the '5' gourmet bar and restaurant in Stuttgart, have been successfully concluded. With the court having already confirmed the plan, the developed solution has since become legally binding and the proceedings can soon be formally terminated. The creditors approved the plan back in early April. He said, "The aim of the proceedings was to develop a solution that would ensure the restaurant's continued existence and serve the creditors' interests. That has been achieved here. With the insolvency plan as part of the investor solution, a financially viable concept that considers the interests of the creditors has been implemented."

A suitable partner to acquire and further develop the business within the framework of the insolvency plan was found as part of the structured process to secure an investor. This ensures the preservation of an important dining establishment and provides the basis for its successful future in the upscale segment. Moreover, all jobs have been saved.

Management at the operating company filed for the opening of debtor-in-possession proceedings with the Local Court of Aalen, as the competent court, in mid-July 2025. The court opened the proceedings in autumn 2025 and appointed Mr Steffen Beck as insolvency monitor.
