# **WORMLAND successfully completes restructuring – PLUTA attorney Torsten Gutmann involved as insolvency monitor**

The Insolvency Court of Hanover decided to terminate the debtor-in-possession proceedings on 31 August 2024. Accordingly, after eight months, the WORMLAND insolvency proceedings have been concluded with the implementation of the restructuring plan approved by the creditors' assembly. The company is now in sole charge of its affairs once again. Having been acquired by Osnabrück-based family business L&T, WORMLAND with its more than 300 employees across Germany has now successfully achieved a fresh start.
