# **X-ray system manufacturer PROTEC files for insolvency – PLUTA attorney Steffen Beck appointed provisional administrator**

PROTEC GmbH & Co. KG filed for insolvency with the Local Court of Heilbronn on 29 August 2024. The court then ordered provisional insolvency proceedings and appointed Mr Steffen Beck from PLUTA Rechtsanwalts GmbH as provisional administrator.

Despite having filed for insolvency, the manufacturer of high-quality medical equipment continues to operate and all orders are being reliably dealt with as usual. Based in Oberstenfeld, near Heilbronn, PROTEC produces X-ray systems for various applications. The business filed for insolvency due to imminent liquidity problems. Sales have declined on account of international competition and the associated increasing price pressure. The company has been unable to fully adjust its costs to take account of the fall in sales in recent months.

“My team and I are in the process of gaining a comprehensive overview of the financial situation and will review the restructuring options that may be considered for the company,” said Mr Steffen Beck. The provisional insolvency administrator convened a staff meeting last Friday: “We informed the staff about the current situation.

The team is motivated and wants the business to continue operating," he added. The employees' salaries are guaranteed until November inclusive thanks to specific substitute benefits provided under German insolvency law. The business currently employs around 30 people. Initial talks with customers and suppliers have been encouraging.

The aim is to find a sustainable long-term solution for the company. Among other things, a structured M&A process will soon be initiated with this in mind. Mr Beck is being supported in the PLUTA restructuring team by Ms Ilayda Keskin-Akmaz (LL.M.) and Ms Maria Fasolidou (LL.B.).

Managing partner Mr Erhard Fichtner emphasised, "Although we find ourselves in a challenging situation, I am confident that we can preserve our company.
